

**TERMS & CONDITIONS FOR LENOVO YOGA URBANSCAPES PROMOTION (The
“Promotion”)**

IMPORTANT: PLEASE READ THESE TERMS AND CONDITIONS (THESE “**TERMS AND CONDITIONS**”) BEFORE ENTERING THIS PROMOTION. THIS IS A LEGALLY BINDING AGREEMENT BETWEEN YOU AND LENOVO TECHNOLOGY SDN BHD (“**LENOVO**”) ESTABLISHING THE TERMS AND CONDITIONS UNDER WHICH YOU ARE ENTITLED TO PARTICIPATE IN THIS PROMOTION. - Step 4 If purchase the pre-ordered Lenovo YOGA Tablet 2 With Windows or YOGA Tablet 2 Pro: Lenovo Exclusive Store or participating Lenovo reseller will provide redemption form.

6. How gifts will be notified.

6.1. The eligible recipients of the gifts will be informed by phone or email by the Program Centre.

7. Claiming a gift.

7.1.
